# The Privacy Policy of Eurogate Logistics for website usage and online marketing

A priority goal for **Eurogate Logistics Ltd.** (a member of the Eurogate Logistics Company Group, (hereinafter Eurogate Logistics), is to protect personal information provided by registered users of the Eurogate Logistics database (hereinafter users) and to ensure the right to informational self-determination.

## Data controller information:

Data Controller is responsible for the preparation of this Privacy Policy, for the compliance to it, for the control of it and for the necessary changes. ## 1. PERSONAL DATA HANDLED

The Company is entitled to handle the following personal data at each service category provided by the Company related it online presence and marketing:

The Company operates the website [www.eurogate.com](http://www.eurogate.com) for the whole Eurogate Logistics Company Group.

The Data Controller proceeds the following data controlling activities related to the website:

### 1.5.1 Subscription to Newsletter

When a user signs up for the Eurogate Logistics newsletter, personal data will be stored as provided by the user: user's name, e-mail address and company name with the aim to send out a newsletter of Eurogate Logistics to him/her. The data will be stored by the Mailchimp service provider to send out information. The stored data is managed by data processor and will not be transferred on to third parties.

Required data by the user for newsletter subscription: name, email address, company name  
The data signed with \*are obligatory to fill in.

### 1.5.2 Career site

The user can send online motivation letter and CV to the Eurogate Logistics based on the Career site published open positions. The data send in the application documents will be stored by the Company and will not be transferred on to third parties.

### 1.5.3. Cookies

The Eurogate Logistics corporate website uses cookies according to the description of the [Hiba! A hivatkozási forrás nem található.](#) All personal data are handled upon the authorization of the website visitor based on the visitor's acceptance of the Eurogate cookie policy. Data are handled for a period of 1 year following the visitor's last entry to the Eurogate website.

## 2. DATA CONTROLLING AIMS AND DURATION

### 2.1 Data controlling aims

The Data Controller use the provided data to ensure fulfilment of its services, so specially for the below purpose:  
Aims related to the operation of the website (www.eurogate.com):

- Contacting, which has the main target of proper information providing for Users, the effective and quick handling of the possible technical problems, system messages related to services;
- Contacting users;
- Newsletter sending;
- Providing information about each service to fulfil information providing task of the Data Controller and to comply with legal requirements;
- Application to open positions published online by Eurogate Logistics, and in case of further permission the storage of data for future open positions.

### 2.2 Duration of data management of online activities

The Data controller handles data until the aim of data handling is still on, so primarily the data are handled related to registration, contact, newsletter sending and application on the career site until the user do not ask for deletion of his/her data and do not withdraw his/her permission of data usage.

## 3. Data controlling claim

In case of registration for newsletter the user expressly and obviously give permission for the Data controller to send emails with marketing content and to handle personal data related to this newsletter sending.

In case of „Open position” applications as well as emails sent to the email addresses of Eurogate Logistics on the career subsite the users give permission to the Data Controller to handle their data. The data handling is executed based on the users' voluntary permission after users' acknowledgement of understanding and agreeing with this Privacy Policy and Data protection document.

In certain cases, the handling, storage, transferring of set of submitted data is done by mandatory legislation, about that fact the Data Controller send notice to user in each case.

The user can only give their own personal data on the website. In case not their own data is submitted, it is the duty of Data controller to get the permission of the affected user.

#### **4. Access of personal data**

Exclusively the Data controller has the right of direct access to personal data.

Eurogate Logistics does everything is expected for the safe storage of data of Clients and Users.

Information by submitting of the data determined in Point 1. are handled with the utmost care and strict confidentiality by the Data Controller. The administrators of the Data Controller have different access rights: some of them have full right, others have limited access and right of data handling.

#### **5. Data transferring**

With the approval of this Privacy Policy and Data protection document the users expressly gives permission by acknowledging the data protection principles of the Data Controller, that the Data Controller transfers data to the service providers contracted directly with the Data Controller. The transferred data are allowed to use only for the execution of the contracted tasks, for further usage the transferred data are not allowed to store or transfer to third party in any form.

The aim of data transfer is to provide tailor-made service for the users, to optimize services provided by the Data controller for the users, to execute the contracted tasks of Data controller. The stored data are not allowed to be accessible for any other third party except it is mandated by law as well as in case it is related to the execution of Eurogate Logistics' contracted obligations.

#### **Data transferring abroad**

It may be that as part of the services provided for users, the collected personal information is mandated to be disclosed to a third party, which may be located outside the European Economic Area (EEA). This can happen when at any given time server is located outside the EEA countries, or if the service provider operates in a country outside the EEA. In case such transfer of personal data to third party is needed, Eurogate Logistics has made the necessary organizational and/or contractual action to ensure that processing of personal data is used only for the purposes mentioned above and with the adequate level of protection.

The Data Controller can transfer personal data for third country data controller or data processor outside the European Economic Area (EEA), in case the user gave expressly permission, or the rules of the valid data protection legislation are met and the right level of protection of data is ensured at the data controlling and data processing in the third country.

The Data Controller transfers personal data to third country in case of international legal aid, tax information exchange and execution of international treaty on the avoidance of double taxation according to the purpose, conditions and data specified in the international treaty.

## 6. Data processor information

The Data Controller uses Data processors, who provides proper guarantees about the compliance to the at all times the applicable data protection legislation, gives priority to the protection of the users' rights, furthermore makes steps for the data protection adequate technical and organizational actions.

## 7. Rights of the user

Data controller give information to the **request of the user about his/her personal data**, the source of these data, the aim, claim and duration of the data controlling, furthermore – in case of transfer of personal data – about the claim of data transfer and addressee. The information can be requested via email sent to this [privacy@eurogate.com](mailto:privacy@eurogate.com) address and via post mail to **EUROGATE LOGISTICS spol. s r.o., Praha 8, Karlín, Sokolovská 100/94** in both cases with the verification of the identity and postal address. The Data Controller has 30 (thirty) days to answer in written format after the arrival date of the request.

The user has the right to **request of rectification of personal data** (indicating the correct data) via this [privacy@eurogate.com](mailto:privacy@eurogate.com) email address and via post sent to **EUROGATE LOGISTICS spol. s r.o., Praha 8, Karlín, Sokolovská 100/94**, in both cases with the verification of the identity and postal address. The Data Controller execute the rectification forthwith and send notice in written format to the user about the rectification.

The user can request the **erasure and limitation** of usage of his/her personal data via this [privacy@eurogate.com](mailto:privacy@eurogate.com) email address and via post sent to **EUROGATE LOGISTICS spol. s r.o., Praha 8, Karlín, Sokolovská 100/94.**, without explanation, with the verification of the identity and postal address. The Data Controller execute the erasure and limitation forthwith of personal data.

The Data Controller set limitations of handling into force in case the User request it. If the data handling has limitation, the related data can be handled except storage in case of permission of user or to present, enforce or protect legal claims, or in case of protection of the rights of other natural person or legal entity or in case of high priority public interest of the EU as well as any member state of EU.

In case the Data Controller do not execute the user's request of data rectification, limitation of handling or erasure, the Data Controller should send in written the fact based and legal reasons of user's request of data rectification, limitation of handling or erasure within 30 days after receiving the request. In case of refusal of user's request of data rectification, limitation of handling or erasure the Data Controller give information for the user about the judicial remedies and the possibility of turning to the National Data Protection and Information Authority.

The user can object to handle personal data,

- If data handling and transfer is needed for execution of the legal obligation exclusively related to the Data Controller, or it is necessary to enforce its legitimate interest of the data controller, the data processor or the third party, except mandatory data handling;
- If the usage and transfer of personal data is done for the purpose of direct solicitation, poll or scientific research, and in any case determined by law.

The Data Controller investigate the object request within the shortest possible time after the submission of the request, but maximum within 15 (fifteen) days, the Data Controller decides about the soundness of the request and informs the user in written about the decision. If the User do not agree with the decision of the Data Controller, as well as the Data Controller miss the above deadline, the User can turn to court after the decision sent or within 30 days from the last day of the deadline.

## **8. Data collected at the usage of website**

In case the user does not give any personal data, information on the website, the Data Controller do not collect and handle any personal data related to the user in the form, the user can be identified.

By visiting the website all users can give their permission to record the data and information subscribed in the Cookie Policy section of this Privacy Policy and Data Protection document and use cookies for this record.

This information can be the data of your computer, tablet or smartphone which are generated at the usage of the website and which are automatically recorded by the Data Controller's system as the result of the technical processes. The automatically recorded data are automatically logged by the system – without the particular permission or action of the user - when the user enter and exit the website.

IP address of the Web page, pages visited by the users, what web browser is being used for browsing places visited previously / after, as well as how long it took for a visit / session.

These data are not linked to any other personal data, so the user can not be identified based on these data. Exclusively the Data Controller has access to these data. These data can be collected only by using different technologies, like cookies, web beacons and logfiles.

These data contain the following information:

**Cookies:** cookies are small text files that are sent to your Internet browser so that when you return to the Site, we recognize your browser and it contains information about the.

### **Logfiles:**

The internet browser automatically forward certain other data as well to the website, as the IP address of the user (pl. 192.168.2.1), the operation system of the user, the type of the web browsers, domain name, browsing places visited previously / after, as well as how long it took for a visit / session.

The Data Controller – as any other website owner – makes analysis these data to define which part of the website is more popular among visitors and to be able to develop the website’s user experience based on the needs of the users.

## **9. Cookie management**

**Eurogate Logistics Group wishes to send cookies to your computer to increase user experience on our webpage.**

**Under the regulations of the European Union, we advise you on how we use cookies.**

This webpage was created to summarize the key information regarding the use of cookies.

Protecting your personal data and speaking frankly about the method of their processing is important to us. These data are informative and help you spend a delightful time on our webpages.

### **So, what is a cookie?**

It is a small text file containing data embedded in your computer by the website you are visiting. Its purpose is for the websites to remember what you dealt with while being there. It may, among others, store whether you clicked on certain links or pages, entered with your user name, read certain pages on the website months or years before.

There are several types of cookies, and without them, websites may not function the way you are used to.

For example, in lack of the cookie required for authorizing the login, the webpage cannot display your profile. Or, the webpage will send a message “we apologize, but you have to log in” each time, since it does not remember who you are.

The Eurogate Logistics Group website provides the best user experience by cookies, and it applies only the most needed and most useful cookies.

Pursuant to the new regulations, we list the types of cookies the website uses for you to be able to decide whether you keep them, erase the existing ones, or disable all when visiting our website.



## **What types of cookies does the Eurogate Logistics Group website contain?**

### **(1) Strictly necessary cookies**

These cookies are fundamental for the visitors to browse the webpage and to use its features. Without these, no services may be provided, the registration and login would be impossible. No user information is gathered for marketing purposes and no note is taken on where you were on the Internet.

### **(2) Performance cookies**

These cookies gather information on the method the website is used, for example which pages you open most frequently and whether you get error messages. No data used for identification is gathered on you, all information is anonymous. They serve only the development of the functions of the website.

### **(3) Functional cookies**

These cookies remember your choices (e.g. language settings) and provide customized features.

They may remember modifications made concerning text size, font size or other parts of the website you may customize. These also provide services you request like watching a video or commenting any blog. Data gathered by them may be converted into anonymous. These cookies are not suitable for tracing browsing activities on other websites.

### **(4) Targeted cookies**

These cookies display ads and messages corresponding to you and your scope of interest. Sometimes, they relate to other websites, like Facebook.

Beside the above four types, cookies may be classified two ways: transient (“session” cookies) and persistent cookies.

- “Session” cookies store operations carried out until the end of a session. “Session” starts by opening the website and ends by closing the website. Then, these cookies are deleted permanently.
- “Persistent” cookies stay on your phone or computer for a specific period. They are activated automatically by visiting a given website.

Cookies can also be own, first-party cookies (internal) or from a third party (external). Internal cookies are set by the Eurogate Logistics Group website, while external cookies are set by others. Eurogate Logistics Group allows the placing of only those external cookies that are approved by the company.

## (2) Performance cookies

Eurogate Logistics Group uses “Performance” cookies in order to:

- Produce statistics regarding the use of our website
- Gauge the failures in order to assist the development of our website
- Test different appearances of the website

Cookies categorized as Performance cookies are NOT used by Eurogate Logistics Group for:

- Remembering your settings and user name after your visit has terminated

By using our website, you agree to the use of performance cookies. Should you not use cookies, we cannot guarantee the proper operation of the website.

## (3) Functional cookies

Eurogate Logistics Group uses “Functional” cookies in order to:

- Remember the settings you made
- Show when you are logged in the webpage (if applicable)

- Share information with the service partners of the webpage. The shared information is required only for the glibness of the function of the service, product or feature, the analysis of the attendance of the website, it is used for no other purpose.

Cookies categorized as Functional cookies are NOT used by Eurogate Logistics Group for:

- Targeting you with advertisements on our website or any other website.

Some Cookies are controlled by other companies on our behalf, though, we do not allow them to use the cookies for other than the listed purposes.

You may decide whether or not to allow these cookies, but should you disable these cookies, we may not be able to provide certain services. If you decide not to use these, it may result our system not remembering that you have cancelled a certain service.

#### **(4) Targeted cookies**

Eurogate Logistics Group uses “targeted” cookies to:

- Connect to social networks like Facebook. Social networks use this information to deliver you targeted advertisements.
- On the website, re-marketing and re-targeting cookies are applied that Google Analytics / Facebook uses for anonymous and general profiling, so that advertisement activity may be pursued later via Google AdWords and Facebook Pixel systems to users with profiles matching or similar to the general profile of website visitors.

You may decide whether or not to use cookies, but if you decide not to use them, some of our services may not work or function. All such cookies are controlled by other companies; therefore, you may also stop these cookies by applying their own tools.

### **Delete cookies**

If you decide to neglect the use of cookies, you may simply delete them from the cookie directory of your browser. You may also set your browser to block cookies or display warning message before storing a cookie.

There are several different browsers, so we will not provide guidance for each of them, but should you have further questions, we recommend you visit the website “All About Cookies”.

If you use Windows Explorer, you need to this:

- Click on “Windows Explorer”.
- Click on the button “Search” in the toolbar.
- Type the word “Cookie” into the search field titled “Directories and files”.
- Choose the place “My computer” in the drop-down menu “Location of searching”.
- Click on the command “Search now”.
- Choose and open scanned directories.
- For selecting the Cookie file, click on the specific Cookie file.
- Push the button “Delete” for deleting the Cookie file.

If you do not have Internet Explorer, click on Help in the Start menu and search for the word “cookies” to find the directory.

If done, some services may not work in our website (or in other websites).

## **10. The data collected during the usage of the website**

The above technologies cannot be collected to identify the users and the Data Controller do not link these data to any data suitable for identification.

The aim of data usage is to ensure the website flawless operation by the Data Controller, to that the data about the usage of the website is necessary and to filter the misuse of the website. In the data subscribed in this document can be used based on the personal preferences of the Data Controller (e.g. the most visited content of the website). On top of the above written the Data Controller can use these data to analyze user trends and to improve, develop website functions and to gain comprehensive traffic data about overall usage of the website.

## **11. Turn-off cookies:**

If you do not want that the Data Controller collect data related to your website usage, you can turn off partially or fully the usage of cookies in the internet browser settings or you can modify the settings of the cookies' messages. However, please note that if you refuse the use of cookies, although you will be able to visit our Web sites, it is possible that some functions will not work properly, and it is also possible that you will not be able to use all the features of the Website and the aimed user experience cannot be ensured by the Data Controller.

## **12. Links**

Our services sometimes link to services run by other companies (e.g. Facebook, LinkedIn, Twitter, Instagram). Those companies have their own privacy and cookies policies. Eurogate Logistics do not take responsibility for the content, data and information protection practice of these websites. If Eurogate Logistics get aware of any misuse of personal data by the linked websites, the link will be removed from the website of the Data Controller.

## **13. Data security**

The Data Controller obliges himself, to care about the data security, and do the technical and organizational actions, and establish those processes and rules, which ensure that the data collected, stored and handled are protected and prevent the annihilation, unauthorized use and unauthorized modification of these data. The Data Controller obliges himself to request from all third party to whom these data were transferred or handover to ensure the requirements of data security.

The Data Controller controls that unauthorized persons do not have access to the data handled, are not be able to publish, transfer, modify and delete these data. Only the employee of the Data Controller can have access to the data handled and Data Controller do not transfer these data to unauthorized persons.

The Data Controller does his best that data is not damaged and annihilated accidently. This obligation is prescribed by the Data Controller for the employees participating in data handling.

Under no circumstances the Data Controller do not collect special data, namely data about racial or ethnic origin, political opinions, religious or philosophical beliefs, or trade union membership, and the processing of genetic data, biometric data for the purpose of uniquely identifying a natural person, data concerning health or data concerning a natural person's sex life or sexual orientation.

In case of data protection incident, the Data Controller without undue delay, latest 72 hours after getting aware of data protection incident notifies the incident to the supervising authority, except the data protection incident do not pose a risk to natural persons' rights and freedoms. In case the notification does not happen within 72 hours, the Data Controller should enclose the reasons proving the delay to the notification.

In case the data protection incident pose high risk potentially to the natural persons' rights and freedoms, the Data Controller should inform the user about the data protection incident without delay.

The Data Controller should include the following information to the Data protection incident document sending to the user:

- Clear information about the feature of the data protection incident;
- Information about the contact name and availabilities of further notice;
- Describe the possible consequences of the data protection incident;
- Describes the actions planned and taken by the Data Controller to mitigate the effect the data protection incident and the disadvantages.

#### **14. Enforcement opportunities**

- The Data Controller does his best, to ensure that data handling is happening according to the valid legislation.
